Out of the earlier panel drawn up on 27.8.82 one person  $wa_s$  appointed  $a_s$  the Chief Executive and as more than three ears have elapsed a fresh panel was prepared.

THE MINISTER OF STATE IN THE DEPARTMENT OF INDUSTRIAL DEVELOPMENT (SHRI M. ARUNA-CHALAM): (a) and (b) There are 25 projects under execution by the Engineering Projects (India) Limited, out of which one is outside the country. The overseas project on hand is likely to be completed by July 86. The others are expected to be completed by the scheduled dates.

भौद्योगिक विकास विभाग में राज्य मंत्री (भी एम० ग्रहणाचलम) : (क) लोक उद्यम सर्वेक्षण 1983-84 के ग्रनसार सरकारी क्षेत्र के 92 उद्यमों ने कुल मिलाकर 1534.37 करोड़ रुपये का निवल घाटा उठाया है । 1984-85 के ग्रन्तिम ग्रांकडे ग्रभी उपलब्ध नहीं हैं। किन्त, केन्द्रीय सरकारी उद्यमों के 1984-85 के उपलब्ध ग्रनन्तिम ग्रांकडों के अनुसार 84 उद्यमों ने कुल मिलाकर 1305.15 करोड़ रुपये का घाटा उठाया है।

(ख) प्रधान मंत्री जी की ग्रध्यक्षता में कोई यथा निर्दिष्ट समिति नहीं गठित की गई है। किन्तु डा० ग्रर्जुन सेन गुप्त की ग्रध्यक्षता में "सरकारी उद्यमों के सम्बन्धी नीति की समीक्षा करने के लिये समिति" गठित की गई थी तथा सरकार इस समिति की सिफारिशों की फिलहाल जांच कर रही है।
