**Joining of Bombay-Delhi and Bombay-Hyderabad flights**

(a) whether it is a fact that the Indian Airlines had recently joined

its flights to Delhi and Hyderabad from Bombay due to under bookings; and

(b) if so, what are the reasons for not informing the passengers through the All India Radio and Doordarshan in time?

THE MINISTER OF STATE IN THE DEPARTMENT OF CIVIL AVIATION (SHRI JAGDISH TYTLER): (a) Yes, Sir.

**Non-availability of essential medicines in Gurgaon O. G. H. S. Dispensary**

3055. SHRI HUKMDEO NARAYAN YADAV: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) whether it is a fact that essential items and medicines such as 'dressings, analgia, /tetracyclin, aspirin are not available at the CGHS dispensary number 73 (Gurgaon);

(b) whether any complaint in this regard has been received by Government; and

(c) if so, what action has been taken thereon?

THE DEPUTY MINISTER IN THE DEPARTMENT OF FAMILY WELFARE (SHRI KRISHNA KUMAR): (a) to (c) There was temporary shortage of certain medicines and dressing materials in CGHS dispensary No. 73, Gurgaon. A complaint was received, which has been looked into. At present all essential medicines including dressing materials are available in CGHS dispensary Gurgaon.
