Incentives for the Family Planning:

3037. SHRI SURESH PACHOURI: Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state*.

- (a) whether to give a vigorous thrust to the family planning programme Govt, have been considering various schemes by providing immediate and long-term incentives;
- (b) whether despite the rise in the iwmber of sterilisations, the achievements have not matched the expectations;
- (c) whether the main reason for this inadequate attention paid so far to the delivery front; and
- (d) if so, whether the latest steps proposed by Govt, in this regard are liikely to reduce the population?

THE, DEPUTY MINISTER IN THE DEPARTMENT OF FAMILY WEL-FARE (SHRI KRISHNA KUMAR)): (a) to (d) A statement showing the Statewise performance of Family Planning Programme during the last three years is annexed [See Appendix CXXXVI, Annexure No. 56] (Strengthening delivery of Family Welfare Service_s and supplies and infrastructure are important components of the strategy for promotion of acceptance of Family Planning. The other components of the strategy include promoting greater community participation at all levels, increasing demand for contraception through improved communication approaches, improved management and optimal utilisation of infrastructure, staff and Services, reorganisation and streamlining of delivery system, intensification ot population education activities in schools and colleges, launching universal immunisation programme to tenhance child survival; increasing the age at marriage etc. Presently only limited incentives are available to those employees of the Central

Government who accept terminal methods of family planning. These include one increment *ot* pay and & per cent rebate on House Building Advance Some State Governments have introduced similar incentives for their own employees and also the Green Card and Lottery Schemes of incentives for acceptors.

The implementation of the Family Welfare Programme is primarily the responsibility of the concerned State Governments. It can reasonably be hoped that with the adoption of the above strategy and effective implementation by the State Government' the desired $goal_s$ of control of population growth will be achieved.
