- (b) whether Government are aware that some Members of Parliament from Andhra Pradesh had submitted a memorandum to the Prime Minister in May-last stressing the necessity for setting up a Free Trade Zone at Visakhapatnam; and
- (c) if so, what is Government's reaction thereto

THE MINISTER OF COMMERCE (SHRI ARJUN SINGH): (a) I. There are two existing and functioning export processing Zones;

- (1) Santacruz Electronics Export Processing Zones, Bombay.
- (2) Kandla, Free Trade Zone Gandhidham. Four new Zones are in the proMjs of being established;
- (1) Falta Export Processing Zone, Falta (West Bengal).
- (2) Madras Export Processing Zone, Madras.
- (3) Cochin Export Processing Zorw, Cochin.
- (4) NOIDA Export Processing Zone. NOIDA (U.P.).
 - (b) Yes, Sir.
- (c) Due to resources constraints, it has not been feasible so far jo include any new export processing zone scheme in the 7th Five Year Plan programme. In case it is decided to have any other new Zones the claim of Visakhapatnam would be considered alongwith other proposals.

 - (2) On_e 20-roomed 1-2 star hotel at Itanagar at an estimated $^c\circ$ st of Rs- "0 lakhs in collaboration with Arunachal

Pradesh Industrial Development and Financial Corporation Limited.
