

have been enacted from time to time according to felt needs. With growth in the industrial and allied activities in the country, it is necessary that these laws are revised and updated in order to safeguard the interests of the workers, particularly their safety, health, welfare and remuneration due to them. This is achieved through a process of continuous consultation with the workers' and employers' organisations and State Governments, as well as, wherever feasible through tripartite meetings. Various amendments to labour laws have accordingly been carried out in the recent past and these exercises are of concurrent nature.
