CHIDAMBARAM): (a) and (b) The views of-the State Governments on the proposal to constitute the Indian Service of Engineers and to reconstitute the Indian Medical and Healh Service arc being ascertained. Some State Governments had expressed their oppositon to the Indian Medical Service. In March 1978, the Gov-rnment decided not to pursue the matter. The position has since been reviewed and consultations are now being held with the State Governments.

(b) Before registering small scale units with pollution potential, the Industries Department of Delhi Union Territory obtains 'No Objection Certificate' or consent letter from the Cenral Board for the Prevention and Control of Water Pollution. As regards medium/large scale units which need Industrial licence, the Industries Department recommends such cases after considering their pollution potential.
