Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

- (a) what are the names of patients who disappeared from different hospitals in Delhi during the last six months;
- (b) whether any investigations have been conducted into these cases:
 - (c) what were the circumstances which these patients each case under disappeared; and
 - (d) what remedial measures Government propose to take in this regard?

THE DEPUTY MINISTER IN THE DEPARTMENT OF FAMILY WELFARE (SHRI KRISHNA KUMAR): (a) A list of ratients who disappeared/absconded from different hospitals in Delhi during the last six months is attached. Sec Appendix CXXVI. Annexure No. 4.]

- (b) In each case a report is immediately lodged with the Police and a phonogram gelegram sent to the registered - address of the patient.
- (c) It is not possible to give the circumstances of disappearance in each and every case. Generally speaking patients could be leaving when they feel frustrated because of a chronic/terminal illness or to avoid the formalities required to be completed to get proper discharge slip.
- (d) Security in the hospital, has been tightened and the staff members have been asked to be more careful in future to check absconding of the patient.
