- -A daily B-737 service on the Delhi Pune-Bangalore route by Indian Air lines.
- -An HS-748 service thrice a week on the Bombay-Pune-Hyderabad rous by Indian Airlines.
- -A doriryer service on Bombay, pune Indore route thrice a week by Vavudoot
- (b) The Civil Aviation Department has plans to carry out extensions modifications of the terminal building, car parking area, approach road etc. at Pune airport luring the current plan period, at an estimared cost of Rs. 40 lakhs.
