Calcutta and Gujarat. As regards rural housing schemes, the HDFC has preferred to watch the progress of its Rural Housing Corporation set up in Gujarat State.

Scheduled Banks:

The State Bank of Tranvancore has agreed in principle to meet 30 per cent of the cost of the Rural Housing Project in two districts of Kerala. The share of the Bank comes to Rs. 39.60 lakhs. The Bank of Maharashtra has also allocated a sum of Rs. 50.00 lakhs for co-financing Rural Housing Scheme during 1986.

A proposal has also been sent to Delhi Cooperative Housing Finance Society, but there is no response from them so far.

THE MINISTER OF STATE OF THE MINISTRY OF WELFARE (SHRIMATI RAJENDRA KUMARI BAJPAI); (a) to (d) The Minorities Commission has so far submitted six Annual Reports out of which four Annual Reports together with the > Action Caken Memoranda on the various recommendations have already been laid on the Table of the House. In the light of the reports submitted by the Commission it is not correct to say that the Minorities Commission has become defunct. Minorities Commission, had recently organised a seminar on Minorities & Education on 1181th & 17th November, 1985. Posts of four Members of the Commission had fallen vacant in the recent past, due to expiry of tenure of the Members. One post has since been filled up on the joining of a new Member. There is no proposal before the Government to wind up the Commission.
