(d) if so, the details of such agencies for ensuring correct selection of beneficiaries under the programmes?

(c) and (d) The Integrated Rural Development Programme is implemented by the district rural development agencies through the existing block machinery. The Panchayati Raj Institutions are also involved in the implementation of the programme. The beneficiaries of Integrated Rural Development Programme are identified on the basis of household survey. According to the guidelines, the list of the identified beneficiaries are to be approved by the Gram Sabha or in an open general meeting of the residents of the village. The list of the assisted beneficiaries is also displayed on the notice boards of blocks and Panchayat offices, in order to ensure that deserving beneficiaries are given assistance and undeserving beneficiaries are eliminated.

The NREP is also implemented by DRDAs. Here also the involvement of Panchayati Raj Institutions in the implementation is envisaged to ensure that the benefits to the community are maximised.
