Talcher Fertilizer Plant

676. SHRI JAGADISH JANI. Will the Minister of AGRICULTURE be pleased to state the details of the steps so far taken by Government to remove the bottlenecks in the functioning of the Talcher Fertilizer Plant?

THE MINISTER OF STATE IN FERTILI. THE DEPARTMENT OF ZERS (SHRI K. NATWAR SINGH): The coal-based fertifizer plant Talcher in Orissa, which was commissioned in November, 1980, suffers from inherent design deficiencies and equipment problems/imbalances. The production in this plant has been adversely affected due to prolonged power cuts. Based on identification of the problems by a Technical Study Group, the following shortterm remedial measures have already been taken to improve the plant performanc:

- (i) Provision of NOX Removal System to prevent choking and corrosion in the Heat Exchangers;
- (ii) Replacement of raw gas pre-coolers with SS coolers;
- (iii) Replacement of collecting electrodes with SS electrodes:
- (iv) Epoxy lining of the new gas line; and
- (v) Replacement of 1st stage distiller tube bundles of Urea plant with improved material.

To overcome the problem of power shortage, a 30 MW Gas Turbine
