*88.PROF. C. LAKSHMANNA: SHRI S. W. DHABE:

(a) whether it is a fact that there is a policy laid down by Government to release DAVP advertisements only to those newspapers, journals and magazines which are registered with the Registrar of Newspapers and are on the approved list of DAVP;
