Responsibility of District MagistrateA Superintendent Police for atrocities on SC/ST

THE MINISTER OF STATE OF THE MINISTRY OF WELFARE (SHRIMATI RAJENDRA KUMARI BAJPAI): (a) and (b) In the guidelines on the prevention and control of crimes on Scheduled Castes issued by the Government of India on 10th March, 1980 and also on 15th April, 1985 to the State Governments, it has been indicated that it should be the personal responsibility of the District Magistrate and Superintendent of Police to ensure that prompt and effective action is taken not only by themselves but by all officers working under them. They should be made responsible for fully achieving the objectives of effectively preventing such crimes, apprehending offenders and ensuring speedy investigation and trial alongwith quick and complete rehabilitation of the victims/families.
