PROF. C. LAKSHMANNA:

Will the Minister of URBAN DEVELOPMENT be pleased to state:

(a) whether it is a fact that Delhi Development Authority has signed an agreement with a firm in Denmark for constructing 20,000 Janata flats;

(b) what are the details of the agreement about price, delivery schedule, amount to be paid to the contractor and foreign exchange involved;

(c) what is the rate per sq. foot agreed to the firm and the present rate per sq foot for constructing the Janata flats in the country;

(d) whether it is also a fact that this agreement has been signed without calling for tenders; and

(e) if so, what are the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOPMENT (SHRI DALBIR SINGH): (a) No, Sir.

Changes in the Master Plan for Delhi

1311. PROF. C. LAKSHMANNA: Will the Minister of URBAN DEVELOPMENT be pleased to state:

(a) whether it is a fact that there is any proposal under Government's consideration to bring changes in the Delhi Master Plan; and

(b) if so, what are the details thereof and the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF URBAN DEVELOPMENT (SHRI DALBIR SINGH): (a) Yes, Sir. Extensive modifications in the Master Plan for Delhi (1962—82) have been proposed by the Delhi Development Authority and are being processed as per Delhi Development Act 1957, as amended from time to time.

(b) Details are being worked out. The modified plan is an exercise in perspective planning upto the year 2001.

Rise in price of skimmed milk powder and butter oil

1312. PROF. C. LAKSHMANNA: Will the Minister of AGRICULTURE be pleased to state;

(a) whether Government are aware that the price of the imported donated skimmed milk powder and butter oil had been rising steadily leading to the rise in price of baby food which is prepared from the skimmed milk powder and butter oil;

(b) what are the names of the countries from which skimmed milk powder and butter oil are being imported and the cost per Kg. thereof and the cost per Kg. at which it is made available to the consumers; and

(c) whether Government are taking steps to contain the prices of these com'

modifies to make these available at cheaper rates?

THE MINISTER OF STATE IN THE DEPARTMENT OF AGRICULTURE AND COOPERATION (SHRI YOGENDRA MAKWANA): (a) The issue price of gift commodities such as skim milk powder, butter oil of the Indian Dairy Corporation has increased over the years, but the allotment of milk powder for the manufacture of infant milk food has been discontinued by it from the calendar year 1982.

(b) The Indian Dairy Corporation (IDC) is receiving gift supplies of skimmed milk powder (SMP) and butter oil from European Economic community (EEC) meant for dairy development programme and, therefore, there is no cost involved in the receipt of these commodities. The current issue price of S.M.P. and butter oil out of I.D.C's pooled stock (received as gift and procured indigenously) is given in the enclosed statement.

(c) The Government is not exercising any price control on these commodities.
