REFERENCE TO THE INCREASE IN CHILD MORTALITY RATE DUE TO CANCER AND INADEQUATE MEDI-CAL FACILITIES

SHRI BIJOY KRISHNA HANDIQUE (Assam): Madam Deputy Chairman, I would like to draw your attention and the attention of the House to a matter of public importance. Cancer, killer disease has now struck the children. Over the years there was a significant drop in child mortality from infectious and congenital diseases. This promise of a marked advance in child health and care, however, has proved to be short-lived, for cancer has already emerged as the principal cause of death after accidents among children in most developed countries.

Madam, in the next few years, experts feel that cancer would become the commonest cause of death of children in India too. Despite not too encouraging results in research on cancer which is still not under control, it is, however, established that paediatric cancer is, to a large extent, controllable due to advances in chemotherapy rudiotherapy and surgery which have led to successful treatment and even cure if detected early. And statistics show that the percentage of detection and recovery in children is higher than that of the adults. But, in India, according to the well-known specialists, delay in diagnosing malignancies is one of the main restraining factors' in obtaining good results in childhood cancer. And, unfortunately our most of the medical colleges do not have a cancer department for thorough investigation and it has been pointed out that doctors pass out of their colleges without acquiring much practical knowledge of diagnosing or treating cancer.

So, Madam, it is imperative that departments for paediatric cancer be introduced in medical colleges without delay. Failure to recognise this impending danger and to launch a time bound programme to combat this danger, in the next few years, I am afraid, may be too late to meet the situation when the cancer strikes the

STATEMENTS BY MINISTERS

Re. assassination of Sant Harchand Singh Longowal, President, Shiromani Akali Dal and a shooting incident at Jullundur

THE MINISTER OF HOME AF-FAIRS (SHRI S. B. CHAVAN): Madam, I rise to make a statement on a very sad and grave tragedy that has taken place in the death of Sant Harchand Singh Longowal, President of Shiromani Akali Dal and on the

shooting incident at Jalandhar resulting in the death of Shri D. D. Khullar, a Congress (I) leader.

A conference of Istri Akali Dal was organised at Guidwara Akal Prakash, Sherpur Village, district Sangrur, on 20th August, 1985. There was a congregation of about 5,000 persons. Santji had just finished speaking and was receiving Saropas when around 5.40 P.M. Santji was fired upon. The bodyguard of Santji fired towards the assailants as a result of which one assailant suffered injuries. The injured person and another assailant were apprehended. The third person managed to escape.

Two .455 revolvers, each alongwith five (5) empty cartridge and one live cartridge have been recovered from the assailants.

Immediately after the incident Deputy Superintendent of Police, who was incharge of Sant Longowal's security, forthwith took Santji to the Civil Hospital at Sangrur but in spite of immediate medical attention Santji succumbed to his injuries. In the shooting which took place within the precincts of the Gurdwara one more person was killed and some others were injured.

The State Government had made arrangements to provide sefurity to Sant Longowal at his place of residence, during his road journeys and at known places of meetings etc. Inside the Gurdwara, a security team of plain clothed police personnel was available with Santji. In addition, an S.P. with a group of commandos had already positioned themselves in the Gurdwara before the arrival of Sant Harchand Singh Longowal. It is most unfortunate that in spite of all these arrangements, this dastardly event has taken place.

It is with a sense of anguish that I have also to inform about the shooting incident at Jalandhar on August. 1985. Three unidentified
