# DR. SHYAM SUNDAR MOHAPATRA;

Will the Minister of PETROLEUM be Pleased to state.

- (a) whether Government's attention' has been drawn to the news-item caption ed 'No significant oil find by ONGC which appeared in the Indian Express dated the 14th May, 1985;
- (b) what was the annual production of oil in the country during the last t,nree years; year-wise;
- (c) what is the estimated oil reserve in the country at present;
- (d) whether there is any possibility of Bombay High wells going dry; and
- (e) what step<sub>s</sub> are envisaged to increase oil production and to trace more oil reserves?

THE MINISTER OF STATE OF THE PETROLEUM (SHRI MINISTRY OF NAWAL KISHORE SHARMA): (a) Yes, Sir. (b)

- (c) The balance recoverable reserves of oil a<sub>s</sub> on 1.1.85 ar<sub>e</sub> estimated at 495 million tonnes.
- (d) Yes, Sir. Only after the recover able quantity of oil has heen produced. At the present level of production the recoverabe reserves are expected to last for about 15 years.

- (e) Some of the steps taken are—
  - (1) Intensified exploration efforts.
- (2) Improving recovery through enhanced oil recovery techniques, repair of sick wells, etc.
- (3) R&D back up and induction of advanced technology in the areas of exploration and exploitation.

SHRI V. GOPALSAMY. Mr. Chairman, Sir, according to the reply given by the hon. Minister, the reserves would last for another 15 years. I want to know whether, unless new reserves are located and tapped, the ratio of annual production to total reserve might fall to 1.15,, and in that case what steps the Government is going to take. I would also like to know from the hon. Minister whether in Bombay High which is producing about 20 million tonnes of oil annually there is any risk of renewing the belts of this field because for every 20 million tonnes of oil taken out of the reservoir 50 million cubic metre, of water should be injected. So far you have taken out 70 million tonnes of oil from the Bombay High wells whereas only 10 million cubic metre<sub>s 0</sub>f water ha<sub>s</sub> heen injected whereas 200 million cubic metres of water should have been injected. So, these wells are facing the danger of depletion. Therefore, I would like to know from the Honourable Minister as to what steps his Ministry is going to take \*o tackle this problem?

### SHRI NAWAL KISHORE SHARMA:

Sir, we are trying to and fo our reserves. It is our endeavour to see that our reserves are added. It is because of this fact that in the Sixth Five Year Plan, the reserves were added to the tune of. 230 million tonnes. For the Seventh Plan also the Working Group has recommended that 276 million tonnes of reserves may further be added. Therefore, we are constantly trying to add to our reserves and in the effort  ${}^{we}hop_e t_0$  succeed.

With regard to the question of Bombay High water injection, I may inform the hon. Member that we have the technical advice from CFD, France.

MR. CHAIRMAN. Second supplementary.

SHRI V. GOPALSAMY. Mr. Chairman, Sir, drilling plans for Rajastha<sub>n</sub> and it<sub>s</sub> offshore exploration in the Andamans have been totally upse<sub>t</sub> due <sup>r</sup>o the meagre allocation of funds. That is the oil sector Teceived Rs. 1,28,000 crore<sub>s</sub> allocation when they had demanded Rs. 3,44.000 crores. What <sup>ste</sup>Ps hi<sub>s</sub> Ministry has taken to tackle this problem? Whether any indication 'has been given by th<sub>e</sub> Planning Commission that the f<sup>un</sup>d allocation will be raised?

### SHRI NAWAL KISHORE SHARMA:

Sir, the Seventh Plan targets have yet to be finalised. Without the finalisation of targets, it would not be fair for me to say that the p<sup>tan</sup> target would be fixed. It is only after the finalisation of the Seventh Five Year Plan the figures would be known.

MR. SHAIRMAN. Mr. B. Satyanara-yan Reddy.

SHRI B. SATYANARAYAN REDDY: Sir, may I know from the Minister whether any exploratory work has been done in the Godavari Basin with regard to the possibility of finding oil apart from gas?

SHRI NAWAL KISHORE SHARMA: With regard to the Godavari Basin, we have not been able to lay hand on oil onshore. But exploratory efforts are going on. I would unce to inform the hon. Member, through you, Sir, to the House that in t'ne Cauvery Basin in the month of July itself we have able of find...
