Import of Drugs

1268. SHRI (MOLANA) ASRARUL HAQ : Will the Minister of CHEMICALS AND FERTILIZERS be pleased to state :

(a) whether it is a fact that Analgin, Betamethasone, Cephalexin Chlorpromazine Hcl, Chlorpheniramine Maleate, Demamethasone, Dextropropoxyphone, Dextrose, Dipyridamol, Framycetine, Sulphate, Furamolidone, Isoptin Hcl, Loperamide, Oxytocin, Pancreatine, Premefhazine, Pyrazinamide and Pyrantel Pamoate are being imported in the country;

(b) if so, the quantity of each drug imported during the last three years, year-

wise alongwith the name, of parties, quantity imported by each, CIF price and source of import;

(c) what was the customs duty imposed on each drug during import and what was the landed cost of each drug;

(d) what was the price of each of the bulk drug taken into account in fixation of formulation price;

(e) whether any difference between the landed price and price taken into account in fixing formulation prices was collected; and

(f) if so, the details thereof?

THE MINISTER OF CHEMICALS AND FERTILIZERS (SHRI VEERENDRA PATIL). (a) and (b) The information as available based on imports statistics maintained by Director General Health Services is attached. (See below) Similar information in respect of remaining drugs as also party-wise imports is not being monitored in this Ministry.

(c) The current rate of customs duty on the drugs referred to in the Statement is 100 per cent (total) *ad-valorem*. The landed cost would vary depending upon c.i.f. import price.

(d) In fixing the prices of formulations based on the drugs referred to in the Statement, the notified indigenous price or the average landed cost of import where there is no indigenous production or the indigenous price has not been fixed was taken into consideration.

(e) and (f) Some reports about the difference between the price allowed in the formulations and the actual purchase/procurement price have been brought to the notice of the Government in respect of Analgin and Dipyrindamol. In respect of such cases, notices have been issued for recovery under para 7 (2) of the DPCO.
