Power project in West Bengal

THE MINISTER OF STATE IN THE DEPARTMENT OF POWER (SHRI ARUN NEHRU): (a) The Teesta Canal Fall I, Teesta Canal Falls II, III. IV Hydro Projects and the Bakreshwar Thermal Project have been cleared by the Central Electricity Authority (CEA) and stand referred for inclusion in the Plan and investment decision. Two generation schemes, viz., Ramman Stage-I and Durgapur Projects Ltd. Unit 7 are under appraisal in the CEA in consultation with the concerned agencies.

- (b) The Scheme Reports were received in the CEA on: Teesta Canal Fall I (March, 1979), Teesta Canal Falls II, in, IV (September, 1982), Bakreshwar (June, 1984) Revised), Falls II, III, IV (September, 1982), Revised) and Durgapur Projects Ltd. Unit 7 (April, 1985).
- (c) The appraisal of power projects is a complex process requiring examination of various techno-economic features of the Scheme Reports. In so far as West Bengal Schemes are concerned, the State Authorities are to submit a Revised Scheme Report for Ramman Stage I; coal availability

for Durgapur Projects Ltd. Unit 7 remains to be confirmed.

ANSARI): (a) to (c) The DTC is operating regular service of Route No. 712 from Kapashera Border to Dhaula Kuan, From Dhaula Kuan, frequent services are available for going to Central Secretariat and I.S.B.T. Due to various operational constraints, it is not possible for DTc to connect all the places in the Union Territory of Delhi with one another by direct services, when convenient change-over facilities are available. Besides, a large number of Inter-State services of DTC and Transport Undertakings are other State connecting Kapas-hera Border with Central Secretariat and I.S.B.T.
