# Dual Price Policy of Kerosene

THE MINISTER OF STATE OF THE MINISTRY OF PETROLEUM (SHRI NAWAL KISHORE SHARMA):

- (a) Problems faced by the States and Territories in enforcing dual pricing of kerosene included:
  - (i) Difficulties in identification of weak and vulnerable sections the society to whom subsidised kerosene was to be distributed.
- (ii) Inadequacy of distribution system to ensure effective implementation of dual pricing.
  - (iii) Possibility of large malpractices and diversion of subsidised kerosene by dealers.
- (b) Kerosene allocations are mainly meant for domestic fuel and lighting needs. In cases of technological necessity, States and Union Territories

can release it for industrial use also from out of their allocation.
