## Registration for manufacture of Rifampicin

1839. SHRI BHAGATRAM MANHAR; Will the Minister of CHEMICALS AND FERTILIZERS be pleased to state:

- (a) whether it is a fact that accor ding to current Import Trade Con Policy every manufacturer has to apply for Registration furnishing certain information before importing Rifampicin;
- (b) if so, what are the names of the formulators, who applied for such registration indicating the date of ap plication, quantity to be imported, source of import and CIF price at which contract with foreign supplier was made;
- (c) what are the names of the companies who have been accorded registration; and
- (d) how many applications are still pending and the reasons therefor?

THE MINISTER OF CHEMICALS AND FERTILIZERS AND INDUSTRY AND COMPANY AFFAIRS (SHRI VEERENDRA PATIL): (a) Yes, Sir.

(b) to (d) This Ministry has so far received 84 applications from Rifampicin formulators for registration of their import contracts. Out of these, 56 contracts have so far been accorded registration. In most of the other cases, certain information/clsjrifica-tion is awaited from the companies concerned.

The quantity to be imported against the contracts, which have so far been accorded registration, exceeds 19 tonnes, The c.i.f. price at which most of these imports have been contracted, ranges between US \$ 250.00 and US \$ 270.00 per kg.
