- (c) On the basis of figures reported by PESA the tentative estimated capital outlay is likely to be approximately Rs. 58.49 crores made up of Rs. 22.37 crores payable to Delhi Development Authority towards the cost of the building based on its preliminary design concept as developed by the architects.
- (d) Barring unforeseen contingencies, the estimated time of completion of the project is four years from the date of commencement of work on the main building.

Banking Facilities for Rural and Urban Areas

1858 SHRI RAMSINGBHAI PATALI-YABHAI RATHVAKOLI: Will the Minister of FINANCE be pleased to state:

- (a) whether Government intends to provide more banking facilities in the rural and urban areas;
 - (b) if so, what are the details thereof;
- (c) how many branches of various nationalised banks have been opened in rural and urban areas of the District of Baroda, Surat and Bulsar of Gujarat and in the Union Territory of Dadra and Nagar Haveli; and
- (d) what are the new phased programme in this regard for the remaining period of 1985 and for 1986, partitularly for the Adivasi and backward areas of Gujarat?

THE MINISTER OF STATE IN THE **FINANCE** (SHRI MINISTRY OF JANARDHAN POOJARI): (a) and The branch licensing policy of the Reserve Bank of India has been oriented towards achieving the basic objective of extending banking facility to regions devoid of or deficient in such facility, mainly in rural and semi-urban areas. Under the Branch Ex-Programme for the period nansion 1982 March April to banks have oppened 9850 new branches upto 31.1.85. Of these, 8548 were in rural and semi-urban centres and 1302 in urban and Metropolitan Port Towns centres. Further, the banks were also at on 28th February, 1985 holding 5251 licences authorisations (Rural 4419. Semi-urban

- 415. Urban and Metropolitan/Port Towns 271) opening new branches in the country. The banks have been allowed time upto 30.9.85 for opening branches against pending licences/authorisations.

- (d) Opening of more branches of banks in Adivasi and backward areas of Gujarat will be considered in the light of the branch licensing policy for the Seventh Five Year Plan Period which is being finalised.
