been transferred from one place to another in that State during May to July, 1&85;

- (b) whether it is also a fact that before transferring them, the said employees have not been given choice of 3 stations as required by the U.P. Government;
- (c) whether employees who have enjoyed longer stay have not beem transferred while others with shorter stay have been transferred;
- (d) whether it is a fact that U.P. Government employees posted in the Directorate (UP) NCC, Lucknow are not transferred out of that city; and
- (e) if the answers to parts (b) and (c) above be in the affirmative, what are the reasons therefor?

THE MINISTER OF DEFENCE (SHRI P. V. NARASIMHA RAO): (a) Yes, Sir.

(b) to (e) The NCC Directorate, Uttar Pradesh receives a half-yearly vreturn which reflects the choice of stations given by State Government employees working with it. Of the 52 employees transferred during the period May-July 1985, 30 were transferred on their request. Information about other cases is being obtained and will be laid on the Table of the House.

Closing of roads to farmers in Devlali

2007. SHRI SHANKARRAO NARAYANRAO DESHMUKH; Will the Minister of DEFENCE be pleased to state:

- (a) whether the traditional roads on the outskirts of the Air Force Station, Devlali in Nasik District of Maharashtra are being closed to the farmers of surrounding villages; and
- (b) if so, what are the reasons therefor?

THE MINISTER OF DEFENCE (SHRI P. V. NARASIMHA RAO): (a) and (b) These roads were constructed by the Air Force for their own use, after the land was requisitioned for defence use in 1941. The roads are in a prohibited area. How-even the villagers are being permitted to use these roads freely, and only subjected to random security checks. This facility is being provided temporarily, until the State Government constructs roads outside the Air Force area for the villagers.

Read users cost study

2008. SHRIMATI USHA MALHOTRA:

DR. LOKESH, CHANDRA:

(a) whether a study called 'Road users cost study' with the assistance of World Bank has been made;

- (b) if so, when the study was initiated and when it was completed;

- (e) if so, what steps have been taken in the matter?

THE MINISTER OF STATE OF THE MINISTRY OF SHIPPING AND TRANSPORT (SHRI Z. R. ANSARI): (a) Yes, Sir.

- (b) The agreement between the Government of India and the World Bank for conducting the Study was signed in January, 1977. The Study was completed in July, 1982.
- (p) The Study has established relationships between the components of the road user cost (such a*, fuel, tyres, spare parts, maintenance labour, lubricants, crew wages, fixed costs, depreciation, passengers' time commodity value and accident costs) and road conditions (such as, pavement width, riding quality, rise and fall and curvature), traffic conditions (such as, volume, composition and speed) and vehicles factors (such as, make, age and horse-power). The study has developed speed-flow relationships under Indian traffic and road conditions. The Study has quantified the cost of accidents and value of time of passengers and commodities in transit.
- (d), and (e) The result_s of the Study are in the form of research findings which are being used progressively in planning, designing and maintenance of roads.
