The price of each of the proposed ships would be D.N. 71.3 million of which 10 per cent is payable by delivery and balance 90 per cent is a loan from a West German financial institution. KFW payable in 24 half yearly instalments commencing 42 months after delivery at interest rate of 5.375 per cent per annum. Government have not taken a final decision on the investment proposal.

Ring Railway for Calcutta

THE MINISTER OF STATE OF THE MINISTRY OF SHIPPING AND TRANSPORT (SHRI Z. R. ANSARI): (a) and (b) Yes. Government are fully aware of the absence of orders for Cochin Shipyard after the construction of five bulk carriers of 75,000 DWT. This has resulted from the cancellation of orders for the sixth ship of 75,000 DWT by M|s. Chowgulas Steamship

Ltd. and cancellation of letter) of intent for three ships of 67,000 DWT by Shipping Corporation of India. The Shipping Corporation have since placed a letter of intent on Cochin Shipyard for the construction of three oil tankers of 86,000 DWT. The proposals with regard to investment decision and design collaboration with a foreign firm are being processed by Government.

Containerisable Cargo

No estimates or study have been made regarding movement of containerisable cargo in our own containers by the end of Seventh Plan.
