various schemes. But to say that for poultry and for piggery how much allocation was made will require another exercise. I can work out the figure and send it on to the hon. Member.

## Lapses in installation of Hand Pumps in Resettlement Colonies in Delhi

\*354. SHRI RAMSINGBHAI PATALI. YABHAI RATHVAKOLI: Will the Minister of WORKS AND HOUSING be pleased to state:

- (a) whether cases have been registered by CBI against some Delhi Development Authority engineers and others for various lapses in connection with installation of hand pumps in resettlement colonies in Delhi and also for construction of buildings, flats and shops etc.:
  - (b) if so, what are the details thereof:
- (c) whether any enquiry has been conducted by Government into the matter; and
- (d) if so, what are the details thereof and what action has been taken against the concerned officers?

THE MINISTER OF PARLIAMEN-TARY AFFAIRS (SHRI H, K, L, BHA-**GAT**). (a) and (b) One case was registered by CBI in 1980 against five Junior Engineers and Assistant Engineers for their failure to satisfactorily account for 66 hands pump machines, 141.65 metres of CI Pipe and 664.95 metres of GI Pipe costing Rs. 25,417.41. No case for construction works of buildings, flats, shops, etc., has been registered by CBI.

(c) and (d) On the basis of CBI report, departmental proceedings were initialed by DDA against these officials. Penalty of stoppage of two increments with cumulative effect was imposed on two officials and a warning was issued to the \* third. CBI did not recommend amy action against the remaining two officials. - 👍 . . . .
