Supply of dress materials to ONGC employees

2278. SHRI BIR BHADRA PRATAP SINGH: Will the Minister of PETRO-LEUM be pleased to state:

- (a), whether any final decision has been taken so far on the tenders for supply of various types of dress matereials for summer and winter uniforms for the employees of Oil and Natural Gas Commission;
- (b) whether any of the public Sector Organisation/Company has participated in such tenders;
- (c) whether any price concession over other tenders has been given to such public sector Undertakings in the matter of material supply to ONGC; and
- (d) if so, the fact thereof and the action proposed to be taken to procure the materials from Public Sector Undertakings?

THE MINISTER OF STATE OF THE MINISTRY OF PETROLEUM (SHRI NAWAL KISHORE SHAR-MA): (a) to (d) Yes Sir. Orders have been placed by ONGC on M/s. National Textile Corporation, New Delhi for supply of Summer Uniforms suitings) and on M/s. (Terycotton Cawnpore Wollen Mills, Kanpur for supply of Winter Unforms (Woollen suitings cloth). Both these organisations are in Public Sector. The price concession upto the prescribed limit has been allowed in respect of these organisations for supply of uniform materials. Purchase of other material has not yet been finalised.
