(c) The current export policy provides for export of basmati rice under Open General Licence. Export of Basmati rice is not canalised through any agency.

THE MINISTER OF STATE IN THE DEPARTMENT OF STEEL (SHRI SINGH): (a) to (d) To en-NATWAR sure equitable distribution of imported scrap vessels it has been decided MSTC would allocate approximately equal tonnage to all shipbreaking units in country. On the basis of anticipated imports during the current year this would work out to an average allotment about 5000 LDTs per unit as against the average capacity of a little more 9000 LDTs of units registered with MSTC. This would mean an average utilisation of more than 50 per cent.

(e) The quantity of imported ships is determined by the gap in the demand for and availability of rerollables from various sources for production of bars and rods planned in the country. The quantity for import during the current year is double the tonnage actually imported during the year 1984-85.

Board for Industrial and Financial Reconstruction

(c) With improvement in the law order situation this problem is expected to be resolved.
