Thimpu talks on the Tamil issue

*431. SHRI SURAJ PRASAD: SHRI N. E. BALARAM:

Will the PRIME MINISTER be pleased to state:

- (a) what are the reasons for adjournment of the Thimpu talks; and
- (b) what additional specific power the Sri Lanka Government are willing to concede to the people of Indian origin in Sri Lanka?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI KHURSHID ALAM KHAN): (a) and (b) The first round of talks between the Sri Lankan Government delegation and representatives of TULF and Tamil militants took place at Thimphu from July 8-13. The Sri Lanka Government delegation put -forward proposals which were essentially based on those put forward during the All party Conference last year. The Tamil representatives did not put forward any specific proposals for discussion but made a declaration of four principle which in their view should be fundamental for settlement of the ethnic problem. At the first meeting, the talks were mainly exploratory in nature. For this reason, it was decided that the talks would be adjourned on 13 th July for respective consultations and have reconvened on August, 12.

SHRI RAJNI RANJAN SAHU: Sir, it is to be highly appreciated that the Government of India is using their good off!-, ces to help the Sri Lankan Government to resolve this problem. And it is also a good thing that the Foreign Secretary, Government of India, has visited Thimphu recently. I would like to know from the hon. Minister whether the Government of India has suggested any concrete step to bring both the parties nearer to each otbe_r

SHRI KHURSHID ALAM KHAN: Sir, the very purpose of the Foreign Secretary's

visit was to bring these people to the negotiating table.

SHRI KHURSHID ALAM KHAN: It is a fact that at the moment there is a stalemate, but all possible efforts are being made to bring them back to the negotiating table.

SHRI JASWANT SINGH: Mr. Chairman. Sir, apparently the distance between the four principles stated by Sri Lankan Tamils and the devolution of district council autonomy which the Sri Lankan Government is working on is at present too far apart. Therefore, I would clarifications threei from the Government. (a) What is the Government of India's ^v>^{ew} about this current distance? (b) What is the Government of India's information about the recent incidents of violence that have taken place in Sri Lanka? And (c): what is the Government of India's estimate about the date of resumption of talks? Sir, T would request that as the hois. Prime Minister is here, rather than fielding the Junior team, he may handle awkward questions himself.

MR. CHAIRMAN: It is for the Ministers to decide. You cannot say who should answer.

SHRI JASWANT SINGH: I can say, Sir,

SHRI RAJIV GANDHI: Mr. Chairman, Sir, the team we field depends on the opposition we face.

MR. CHAIRMAN: Do you v.'ant to add anything?

SHRI KHURSHID ALAM KHAN: I would like to assure the honourable Member that the junior team is good enough to face any Opposition.

As far as the distance is concerned, we are trying to narrow down the distance and the differences. As regards the likely position of the talks, we are making all efforts that these talks should be resumed.

SHRT ALADI ARUNA Alias V. ARU-NACHALAM: The House is aware of the. fact that while the Thimpu tulks going on, Tamil people were being ruthlessly massacred by the Sri Lankan army with the result the Tamil representatives have withdrawn from the talks. In view of this position, will our Government come forward and insist on the Sri Lankan Government withdrawing the army from Tamil areas as a condition to resume the talks? Secondly, it seems that the mission

of Shri Romesh Bhandari is not successful and has caused undue hardship to the Tamil people in Sri Lanka. Since his mission is not at all successful, will the Government remove Shri Romesh Bhandari and ask Shri Parthasarathy to deal with the matter further?

MR. CHAIRMAN: No question of individual's names here.. It is not proper.

SHRI KHURSHID ALAM KHAN; In the first instance I would say that personalities are not involved in these matters. We feel that it is rather unfortunate that there have been breaches of the ceasefire agreement and we hope that these breaches will not be continued. We feel very sorry for what has happend so far. As far as the hardship caused by the visit of Shri Romesh Bhandari is concerned. I do not know how a hardship can be caused to anybody. He has gone, there to bring them to the negotiating, table.

SHRI V. GOPALSAMY: Despite the visit of Shri Ramesh Bhandari and despite our best efforts at Thimpu, in violation of the ceasefire agreement Tamils in Sri Lanka have been butchered, massacred, for the past few days. Everytime you are' saying that they will come to the negotiating table and they are sending delegations. And all the time the Sri Lankan Government is going on purchasing large. quantities of military hardware, war planes and naval ships from South Africa, Italy and Red China. Under these ' circumstances the Tamils in Sri Lanka are very nuich frightened to face another blood balh. When they are expecting solace and succour from the honourable Prime Minister of India our sending a cricket term to Sri Lanka has only injured the feelings of the Tamils there. May I request the honourable Prime Minister to take effective steps to protect the Tamils who are lool-ing to the Indian Prime Minister for solace and succour?-

SHRI KHURSHID ALAM KHAN: As you know, the Prime Minister is very concerned and is taking every step, is doing everything possible to use I::-tin's good offices to end this problem. Bet at the same I would certainly like to submit that

SHRI KHURSHID ALAM KHAN: I have already said that the breach of the ceasefire agreement is very unfortunate and many innocent lives have since been lost. But still we are making all efforts ta ensure that these talks are resumed.

May I suggest, Sir, through you to the honourable Prime Minister that the issue has come to such a stage, such an impasse—that it needs a talk between our gallant Prime Minister and the Sri Lankan President, Mr. Jaye-wardene? Only these two can solve this problem. Mr. Romesh Bhandari is doing quite a good job, I think. But, Sir,....

SHRI V. GOPALSAMY: Do not equate our Prime Minister with Mr. Javewardene. * (Interruptions).

MR. CHAIRMAN: No, please.

SHRI V. GOPALSAMY: I object to that, Sir.

DR. SHYAM SUNDAR MOHAPATRA: I would like to know whether it can be taken up at the highest level.

SHRI KHURSHID ALAM KHAN: Sir, our Prime Minister k already in contact with the President. Mr. Jayewardene, and everything possible will be done to ensure that the talks are re umed.

MR. CHAIRMAN: Yes, Mr. Ray.

SHRI DEBAPRASAD RAY: Sir, is it a fact that the Government is deriving inspiration from the fact that while negotiations were going on between America and Vietnam in France, the war was being waged for 2-1/2 years or so and, finally, the inegotiations were agreed to?
