## Development of Tourism in Kerala

2645. SHRI K. GOPALAN: Will the PRIME MINISTER be pleased to state the details of the plans of the India Tourism Development Corporation for development of tourism in Kerala during the Seventh Five Year Plan period?

THE MINISTER OF STATE IN THE MINISTRY OF TOURISM AND CIVIL AVIATION (SHRI ASHOK GEHLOT): The VIIth Five Year Plan of ITDC does not include any specific scheme for development of tourism in the State of Kerala. However, a lumpsum provision of Rs. 5 crores exists in the VIIth Plan for joint venture schemes. Such schemes can be worked out in Kerala also in consultation with State Government/State Tourism Development Corporation subject to satisfactory feasibility study.

## Hotel Samrat in Delhi

2646. SHRI K. GOPALAN: Will the FRIME MINISTER be pleased to state:

- (a) the date of the opening of the ITDC Hotel Samrat in Delhi;
- (b) what has been the capital investment in this hotel and by when it is supposed

- to break even according to its project report;
- (c) the total profit earned by the hotel since its opening till 30th June, 1985;

THE MINISTER OF STATE IN THE MINISTRY OF TOURISM AND CIVIL AVIATION (SHRI ASHOK GEHLOT):
(a) Hotel Samrat was commissioned on 14

- (a) Hotel Samrat was commissioned on 14 November, 1982.
- (b) The total investment on Hotel Samrat was of the order of Rs. 19 crores. The Hotel, according to the project report, is likely to break even in the 5th year of operation i.e. 1986-87.
- (c) As on 30-6-85, the Hotel has made an operating profit of the order of Rs. 87 lakhs and incurred a net loss of Rs. 437 lakhs.
- (d) The Hotel is still within its gestation period and is incurring huge debt repayment liability.
- (e) The steps to promote the hotel include securing international linkages for its chain use by foreign tourists and intensification of marketing and sales efforts both in the country and abroad.
