(b) and (c) Among the States in the North-Eastern Region, Assam which is one of the nine educationally backward States, is receiving Central assistance for opening of non-formal education centres on (1) 50:50 sharing basis for NFE centres opened by the State Government for the children (both boys and girls in the age-group 9-14 and (2) on 90:10 sharing basis for centres meant exclusively for girls. Voluntary agencies in the State receive 100 per cent assistance for running such centres. Assistance for appointment of women teachers in primary schools is also given to the State on 80:20 sharing basis.
