II class sleeper berths at major Railway stations

THE MINISTER OF RAILWAYS (SHRI BANSI LAL): The number of additional second class sleeper berths made available as a regular measure by various trains during the period 1-4-1984 to 31-7-1985 at Delhi Junction, New Delhi, Howrah, Bombay V. T., Bombay Central, Kanpur and Lucknow was about 1000, 6260, 200, 250, 1400, 440 and 330 respectively.
