THE MINISTER OF STATE OF THE MINISTRY OF SUPPLY AND TEXTILES (SHRI CHANDRA SHEKHAR SINGH): (a) Yes, Sir. As per the present indications, there is expected to be a bumper jute crop during the current jute season 1985-86 provided the weather conditions remain favourable.

- (b) Yes, Sir. There has been a decline in raw jute prices recently.
- (c) and (d) A communication has been received from the State Government of West Bengal wherein they have ex pressed the view that there may be a dec line in raw jute prices in view of the ex pectations of a bumper crop. With a view to protecting the interests of growers, the Government have already announced the minimum statutory price of raw jute and mesta for the jute season 1985-86 (July-June). The Jute Corporation of India has also been made responsible to under take price support operation to the ex tent necessary. Instructions have been given to begin purchases even if the price is Rs. 25 more than the minimum support price.

It has also been decided to establish a new Mint and steps afe being taken to implement this decision.

Foreign exchange racket

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE JANARDHAN POOJARI). (a) and (b) The Government is alive to the problem of foreign exchange racketeering. The Foreign Exchange Regulation Act, 1973 contains adequate provisions to deal with the foreign exchange racketeers. The Enforcement Directorate (Foreign Exchange Regulation Act) remains vigilant in this regard and takes appropriate action under the Foreign Exchange Regulation Act and aho for preventive detention under the Conservation of Foreign Exchange and Prevention of Smuggling Activities Act, against such racketeers. The drive against such unauthorised transactions is a continuous process and the matter is constantly kept under review for taking annroprnte measures with a viw to curbing the same.

(c) During the first six months of the current year, 159 persons were arrested uinder the Foreign Exchange Regulation Act, by the Enforcement Directorate.
