- (11) a greater involvement of voluntary being agencies is sought of IRDP implementation schemes, including TRYSEM, to enable new types of family oriented projects to be implemented in a most effective manner;
- (12) a new system of concurrent evaluation on the basis of taking up 30 districts 72 blocks and a group of 10 current beneficiaries and 10 beneficiaries who received their assistance two years ago, per month is being introduced to have 8 closer monitoring of the programme.
- (b) During the Sixth Five-Year Plan, against the target o- 9.42 lakh families, the actual coverage of beneficiaries was 9.22 lakh families. An amount of Rs. 8751.86 lakhs was utilised. The physical and financial achievements as a percentage of the targets are 97.85 per cent and 79.63 per cent respectively. 44.51 per cent of the families assisted belonged to SC/ST.

During the current financial year, up to June, an allocation of Rs. 250.25 lakhs has been utilised and 15,017 families assisted under the IRD Programme. The number of SC/ST families covered is 9,984.

Allotment of land to Landless

- SHRI RAMSINGBHAI PAT-ALIBHAI RATHVAKOLI: Will the Minister AGRICULTURE AND RURAL DEVELOPMENT be pleased to state:
- (a) whether it is a fact that the Central Government have issued some guidelines and directives to the State Governments and Union Territories for the allotment of land to landless families belonging to Scheduled Castes and Scheduled Tribes;

- (c) what is the response from the State Governments and Union Territories?

THE MINISTER OF STATE IN THE DEPARTMENT OF RURAL DEVE-(SHRI **CHANDULAL** LOPMENT CHANDRAKAR): (a) and (b) The National Guidelines issued in 1972 on land ceiling laws stipulate that while distributing surplus land priority should be given to the landless agricultural workers particularly those belonging to Scheduled Castes and Scheduled Tribes.

(c) According to the latest reports from State Governments and Union Territories under the revised ceiling laws 22.61 lakh acres have been distributed to 17.00 lakh beneficiaries which includes 11.50 lakh acres which have been distributed to 9.27 lakh beneficiaries belonging to Scheduled Castes and Scheduled Tribes. Thus 50.90 per cent of the area so far distributed has been given to Scheduled Castes and Scheduled Tribes while the percentage of Scheduled Castes/ Scheduled Tribes beneficiaries is 54.4 per
