

**Withholding of incentives to passengers travelling to Nepal**

261. SHRI VISHWA BANDHU GUPTA:

Will the PRIME MINISTER be pleased to state:

(a) whether it is a fact that the Indian Airlines has recently discontinued the incentives given to the passengers travelling to Nepal during summer; and

(b) if so, what are the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF TOURISM AND CIVIL AVIATION (SHRI ASHOK GEHLOT): (a) Yes, Sir.

(b) Keeping in view the growth in traffic and other market considerations, a commercial decision has been taken by Indian Airlines and their pool partners Royal Nepal Airlines not to reintroduce Indo-Nepal excursion fare during summer this year.

**Abolition of the Freight Equalization policy**

(b) if so, what are the details thereof and the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF PLANNING (SHRI K. R. NARAYANAN): (a) and (b) As a result of the recommendations made by the National Transport Policy Committee (Pande Committee^

the Government have already accepted in principle that the existing freight equalisation on steel should be phased out gradually subject to the subsidisation of transport for remote, in-accessible and isolated areas. Necessary steps are being taken by the Department of Steel to work out suitable schemes/modalities to phase out freight equalisation. No proposal for abolition of the telescopic freight structure for coal purchased by the Railways is presently under consideration. The justification for telescopic freight structure lies in the fact that the cost of transportation tends to become lower with increase in distance.
