ge and medium sector, 2143 units have not yet set up effluent treatment plants as required under the law.

- (b) The measures taken by the Government include the following:
 - (1) Minimum national standards have been evolved in respect of various types of polluting industries and phased programme has been launched for their implementation;
 - (ii) Emission limits for air polluting industries have been prescribed;
 - (iii) Air pollution control areas have been declared;
 - (iv) Financial incentives are given to industries for installation and satisfactory performance of pollution control equipment; and
 - (v) Tax concessions are given for shifting of polluting industries from congested areas.
- (c) Prosecutions have been launched against 515 industrial units for violation of laws.

Transistor bomb explosions in the Captal

- (b) 51 persons were arrested in connection with these blasts. The cases are pending investigation. On completion of the investigation, charge sheets will be filed against the accused persons in appropriate courts.
- (c) No, Sir. No separate inquiry was ordered or conducted into these cases.
