## Shelving of Mangalore and Karnal Rfinery projects

Will the Minister of PETROLEUM be pleased to state-

(a) whether Government's atten tion has been drawn to the reported statement of the Chairman Hindustan Petroleum Corporation which was contrary to the assurance given on the floor of the House regarding shelving of! Mangalore Refinery;

(b) if so, whether the refinery pro. jects at Mangalore and Karnal have been shelved due to a cut in the plan funds; and

(c) if *so*, what was the total cost of these projects and how far the  $\$  funds have fallen short?

THE MINISTER OP STATE OF THE MINISTRY OF PETROLEUM (SHRI NAWAL KISHORE SHAR-MA): (a) to (c) In a routine press t conference the , Chairman cf Hindustan Petroleum Corporation Limited had referred to the absence of. adequate provision for public sector outlay in the plan of his Company for the Mangalore Refinery.

The seventh plan is yet to be finalised. However, due to a constraint on public sector resources, other avenues |or financing new refinery projects, like Mangalore and Karnal are being, explored. These refineries are expected to cost about Rs. 1300 crores each.

THE MINISTER OF STATE OF THE MINISTRY OF PETROLEUM (SHRI NAWAL KISHORE SHAR-MA). (a) to (ic) The first advertisement for IOC's LPG dealerships at Dwarka and Khambhalia was issued on January 21, 1984. A letter of intent for the dealership at Dwarka was issued in March, 1985 and it is expected to be commissioned within two months. Selection of a dealer for the Khambhalia dealership is expected to be made soon by Oil Selection Board (West).

## Shifting of Rajkot G.P.O.

(a) whether it is a fact that the. main office of the General Post Office at Rajkot has been shifted to a new high rented building; if so, what are the details in this regard;

(b) what is the monthly rent of that building; and

(c) the reasons for vacation of the previous premises; whether it is a fact that construction of a new build ing in the old place of G.P.O. Rajkot is being planned?

THE MINISTER OF STATE OF THE MINISTRY OF COMMUNICATIONS (SHRI RAM NIWAS MIRDHA): (a) Yes, Sir. Rajkot Head Post Office has been shifted, to a rented building which has a carpet area of 10,984 Sq. Ft. The building was renovated by the landlord at his own cost before occupation by the-Post Office.
