Modernisation of Cuddal, ore Port

- (a) whether Government are aware that the Cuddalore Port in Tamil Nadu is not fit for use of pasesnger and freight ships because of lack of proper facilities;
- (b) what is the passenger and freight traffic during the last three years from the port, year-wise; and
- (c) what steps Government propose to take to improve and modernise the Cuddalore Port so as to re-Leve congestion at the Madras Port and also to give boost to the industries in the surrounding areas of the Port?

THE MINISTER OF SHIPPING AND TRANSPORT (SHRI K. VI-JAYA BHASKARA REDDY): Cuddalore Port is a lighterage port where ships anchor at mid-stream and cargo is transferred between ship and shore by lighters. The Port has 1135 metres of wharf length for berthing such lighters. The port is also equipped with cranes, sheds, stacking area, etc. for handling cargo.
