Sahar International Airport. Information in respect of the number of foreign nationals, Indian nationals including Indian contacts and airlines staff found involved in smuggling activities during the years 1982, 1983 and 1984 (upto June) is furnished below:—

However, there are no reports indicating general connivance by ground staff and policemen posted at the airport with smugglers. As and when any specific case comes to notice, the matter is enquired into and appropriate action as warranted is taken.

(c) The Custom authorites at the Sahar International Airport remain vigilant in the matter. The preventive and intelligence measures at the airport have been further intensified. The pattern of smuggling at the airport is kept under constant review for taking appropriate action against persons found involved in smuggling activities.

## Longer there for chief executives of pub-... lic sector enterprises

# 1458. SHRI SURESH KALMADI: SHRI S. W. DHABE:

Will the Minister of FINANCE be pleased to state:

(a) whether there is any proposal under Government's consideration to give longer

tenure to the Chief Executives of public sector enterprises;

- (b) if so, what are the details thereof and by when a decision is likely to be taken in the matter; and
- (c) whether Government propose to ensure that the chief executives are made responsible to achieve the set targts?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI S. M. KRISHNA): (a) Yes, Sir.

- (b) The proposal is to give full-time Board level appointees in the Central Public Sector Enterprises a tenure of five years or till the age of their superannuation, whichever is earlier. The decision is likely to be taken soon.
- (c) The Chief Executives are responsible for achieving the targets set for them and Government periodically reviews their performance.

THE DEPUTY MINISTER IN THE MINISTRY OF FINANCE (SHRI JANARDHANA POOJARY): (a) and (b) In terms of the provisions of the Public Financial Institutions (Obligation as to Fidelity & Secrecy) Act, 1983 and other statues governing the operations of the public financial institutions, information

relating to individual constituents cannot disclosed. Hence, the unit-wise information relating to amounts sanctioned and names of project which are awaiting sanction as asked in the question cannot be disclosed. However, according to information readily available, sanctions for projects in specified backward areas in 1982-83 (July—June) amounted to Rs. 852.4 crores in the case of IDBI and Rs. 157.83 crores in the case of IFCI. In the case of ICICI direct assistance sanctioned to projects in backward areas amounted to Rs. 189.2 crores for the year ended December, 1983.
