### Use of Container Service in Shipplug **Industry**

### 1491. SHRI K. MOHANAN; SHRI NIRMAL CHATTERJEE:

Will the Minister of COMMERCE be pleased to state the reasons for which Government are allowing the managements in the shipping industry to use the facility of container service and other job-killing devices when the country is facing acute unemployment problem?

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE AND IN THE DEPARTMENT OF SUPPLY (SHRI NIHAR RANJAN LASKAR); Containerisation primarily aims at faster, more secure and damage free transportation and handling of cargo. Shipping being an international industry adequate containerisatlon of the fleet is necessary in order to enable Indian Shipping to compete; or atleast secure a reasonable share in the country's export/import trade as also cross trades. Otherwise, the trading opportunity for ships will be reduced which will also have an impact on the employment opportunity at ports and on ships, in this context it has also been decided to introduce container technology in some of the major ports in the country in order to handle container ships and containerised cargo. It wiH not be correct to say that there is any loss of employment opportunities as a result of introduction of containerisation and other modem technologies in the port and shipping industries.

#### Construction of Airport at Salem and Tuticorin

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI S.M. KRISHNA): (a) Proposals for switch over to Industrial DA formula were received from the Tea Trading Corporation of India Ltd., Manganese Ores (India) Ltd., and Hindustan Paper Corporation Ltd. and they have been approved by the Government. Each public sector undertaking has a certain existing pay structure anil fringe benefits which is laken into account while approving the switcr over to Industrial DA and related Scales of Pay. As such it would not be feasible to indicate any general patter, of details.

(b) Negotiations for the adoption of Industrial DA Formula and related Scales of Pay are in progress in a few enterprises.
