

THE MINISTER OF STATE IN THE MINISTRY OF TOURISM AND CIVIL AVIATION (SHRI KHURSHEED ALAM KHAN): (a) Yes, Sir.

(b) Subject to acquisition of Dornier aircraft economic viability of operations and availability of infrastructure facilities, Vayudoot has plans to connect the following stations with the new aircraft by 1984-S5:—

2. Cuddapah
3. Warrangal
4. Mysore
5. Calicut
6. Ratnagiri
7. Nanded
8. Surat
9. Rai Bareli
10. Bikaner
11. laisalmer

(c) Yes, Sir. Indian Airlines has received requests for introduction of Bombay—Varanasi—Bombay service.

(d) Indian Airlines would consider operating this service after its capacity has been augmented and if justified by the anticipated volume of traffic.

Harassment of Indian Fishermen by Coast Guards

♦240. PROF. B. RAMACHANDRA RAO: Will the Minister of DEFENCE be pleased to state:

(a) what steps are being taken by Government to ensure that Indian Fishermen engaged in deep-sea fishing are not harassed by the Coast Guard authorities;

(b) whether it is a fact that Government have received representations in this regard, especially from the fishing industry, based on the East Coast; and

(c) if so, what steps Government have taken in the matter?

THE MINISTER OF DEFENCE (SHRI S. B. CHAVAN): (a) to (c) No representations either from the fishermen or fishing industry have been received by

the Government. However, complaints of a general nature from two Hon'ble Members of Parliament have been received recently. Although no specific instance of harassment of fishermen by the Coast Guard was listed in these complaints, yet necessary orders have been issued to Coast Guard ships to exercise due care and ensure that fishing operations are not interrupted and no inconvenience is caused to the Indian deep-sea fishing trawlers.

Foodcrafts Institutes

@1437. SHRI M. M. IACOB: Will the Minister of TOURISM AND CIVIL AVIATION be pleased to state:

(a) what is the number of foodcraft institutes which are offering diploma or degree courses in the country;

(b) whether Government have received any representation from the Government of Kerala to upgrade the foodcrafts institutes in Kalamasserry in Kerala; and

(c) if so, what action Government have taken on this proposal for starting post graduate courses or increasing the number of seats in the existing Institute?

THE MINISTER OF STATE IN THE MINISTRY OF TOURISM AND CIVIL AVIATION (SHRI KHURSHEED ALAM KHAN): (a) 12 (Twelve) foodcraft Institutes, offering craft and diploma courses, are functioning in different parts of the country.

fb) Yes, Sir.

(c) Keeping in view the financial and technical constraints; it has not been possible to accept the proposal for starting 3 years diploma courses for the present. No proposal for increasing the number of seats has been received.

Loan sought from World Bank by various States for Bus Transport system

1433. SHRI T. THANGABALU: Will the Minister of FINANCE be pleased to state:

(a) whether it is a fact that a number of State Governments have asked the World Bank for financial assistance for their nationalised bus transport systems during the last five years;

(b) if so, what are the names of the States which have sought such assistance;

(c) whether the World Bank has stipulated conditions for the grant of these loans; and

(d) if so, what are the details thereof?

THE MINISTER OF FINANCE / (SHRI PRANAB KUMAR MUKHERJEE); (a) and (b) During the last five years, Government of India has obtained World Bank group assistance for only one transport system viz. the Calcutta Urban Transport Project. In addition to this, there is a transport Component in the Second Madras Urban Development Project also.

(c) and (d) Under the provisions of both these Agreements, the Government of West Bengal and the Government of Tamil Nadu are required to carry out or cause the implementing authorities to carry out the project with due diligence and efficiency and in conformity with appropriate administrative, financial and engineering practices and are required to provide as needed the funds, facilities, services and other resources for the purpose.

Airport near Arakonam for Defence Services

(a) whether there was any scheme under Government's consideration in 1977 to have a defence airport near Arakonam in Tamil Nadu;

(b) if so, what are the details of the expenditure incurred on this project so far and

(c) the stage at which the project stands now?

THE MINISTER OF STATE IN THE MINISTRY OF DEFENCE (SHRI K. P. SINGH DEO), (a) Yes, Sir.

(b) So far, an expenditure of Rs. 5.67 lakhs has been incurred for the preliminary works like soil investigations, survey of the area, temporary services/accommodation etc.

(c) The development plans of the Airport are being finalised.
