स्वास्थ्य श्रौर परिवार कल्याण मंत्रालय में उपमंत्री (कुमारी कुमुदबेन एम॰ जोशी): (क) हां। इस मंत्रालय की 1967 के बाद ऐसी डिग्नियां प्राप्त करने वाले छात्रों की संख्या के बारे में कोई जानकारी नहीं है।

# Direct rail link between Bombay and . Tirunelveli

1631. SHRI V. GOPALSAMY: Will the Minister of RAILWAYS be pleased to state:

- (a) whether any memorandum has been received by Government from the Bombay Tamil Pervai requesting for a direct train between Bombay and Tirunelveli;
- (b) if so, what are the details thereof;
- (c) whether the suggestions made therein have been considered; and
- (d) if so, what steps are being taken to provide a direct train link between Bombay and Tirunelveli?

THE MINISTER OF RAILWAYS (SHRI A. B. A. GHANI KHAN CHOUDHURY): (a) Yes, Sir.

(b) The requests made include (i)

running through coaches between Bombay and Tirunelveli, (ii) extension of Island Express to Tirumelveli/Kanniyakumari, (iii) combining 129/130 Udyan Express and 25/26 Island Express with slip coaches for Tirunelveli and (iv) running a train between Bombay VT and Kanniyakumari.

- (c) Yes Sir.
- (d) The volume of traffic offering between Bombay and Tirunelveli does not jutify introduction of a direct train. Besides, a direct train by all B. G. route will be longer involving enhanced fares Passengers at present prefer to travel with a change over at Madras by M. G. The other suggestions made involve drastic changes in the existing pattern of services which is not desirable and requires tion of additional resources which are not available. However, 81/82 Bombay-Trivandrum Jayanti Express has since been extended upto Kanniyakumari and passengers proceed to Tirunelveli with a change over at Negercoil.

## Unami system of medicine in C.G.H.S. Dispensaries

THE DEPUTY MINISTER IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (MISS KUMUDBEN M. JOSHI): C.G.H.S deneficiaries are already availing medical facilities from existing Unani C.G.H.S. dispensaries/ Units.

m OF}$ HEALTH FAMILY WELFARE (MISS KUMUD-BEN M. JOSHI); (a) and (b), A loan of Rs. 2.00 lakhs was sanctioned to Hindustani Dawakhana in the year 1953, to develop the institution to increase its production and sale of medicines.

The management of Ayurvedic and Unanı Tibbia College Deini of which Hindustani Dawakhana is rests with the Tibbia College Board and autonomous body under the provision of the Tibbia College Act 1952. The Delhi Administration, which is associated with the Board is considering measures to develop the Dawakhana.

#### Doubling of Ernakulam-Palghat Broad gauge line

1634. SHRI V. GOPALSAMY: Will the Minister of RAILWAYS be pleased to state:

- (a) the amount of money allotted for doubling of the broad gauge line between Ernakulam and Palghat:
- (b) the amount spent out of it so far:
- (c) how much of the line has since been doubled; and
- (d) by when the whole work is likely to be completed?

THE MINISTER OF RAILWAYS (SHRI A. B. A. GHANI KHAN CHOUDHURY): (a) and (b) Against a total anticipated cost of Rs. 38.27 crores, for various Doubling projects, between Ernakulam and Palghat, a sum of Rs. 30.13 crores has been spent up to March 1984 and Rs. 5.99 crores allotted for 1984-85. The expenditure up to 30-6-1984 is about Rs. 33.19 crores.

(c) 104.63 Kms. of the line has been opened with Orthodox Doubling, addition to 15.43 Kms, which has also been opened for goods traffic.

(d) The work is expected to be completed in 1985-36, subject to availability of resources.

(c) and (d) The entire line has already been opened for passenger traffic.
