-(a) to (d) Government are aware of the news item. Government had 'received information that a group of Sikhs had slipped across to Pakistan from the border areas of Poonch in the Jammu Region. Patrolling in this area has been further intensified and security measures tightened.

(c) what action Government have taken in this regard?

(a) whether Governments' attention has been drawn to the news item which appeared in a section of the press on the 23rd June, 1984 to the effect that insurgents and smugglers were coming to India freely from Burma;

(b) whether it is a fact that during Burman's Foreign Minister's recent visit to India this subject; was not taken up by the Government of India;

(c) if so, what are the reasons therefor; and

(d) what steps are being taken to check insurgents and smugglers coming freely from Burma?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRIMATI RAM DULARI SINHA):, (a) Since the name of newspaper has not been mentioned, the particular news item could not be ascertained. However, the Government have information about some insurgents and smugglers coming to India from Burma.

(b) and (c) .No, Sir.

(d) Security Forces in adequate strength are developed along Indo-Burma to check infiltration/ex-filtration of the insurgents and other illegal trans border movement. The Customs field formations on the Indo-Burma border are keeping constant vigil. Appropriate anti-smuggling measures are taken in coordination by the concerned Central and State Government authorities.
