THE MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRIMATI MOHSINA KIDWAI): (a) and (b) The two major programmes for providing wage employment in the rural areas are the National Rural Employment Programme (NREP) and the Ruml Landless Employment Guarantee Programme (RLEGP). The NREP envisages genera, tion of additional employment opportunities for the rural unemployed and underemployed, including the landless. However, it is the RLEGP which has, among it» other objectives, the objective of improving and expanding employment opportunities for the rural landless with a view to provide guarantee of employment to at least one member of every landless labour household upto IOO days in a year. An amount of Rs. 230.0 crores has been earmarked fOT the current year i.e. 1984-85 as the Central allocation under NREP. Aa equal amount is to be provided by the State|Unlon Territory Governments as their matching contribution under this Programme. An employment generation target of 309.129 million mandays has been fixed under the NREP for the current year and is expected to be achieved fully. Tn the case of RLEGP an amount of Rs. 500.0 crores has been earmarked under the Programme and an employment generation target of 300 million mandays has been fixed.
