Improvement in the Service Conditions of Employees in the Data Processing Unit in Directorate General of Employment and Training

2079. SHRI BIR BHADRA PRATAP SINGH: Will the Minister of LABOUR AND REHABILITATION be pleased to refer to the answer to Unstarred Question 968 given in the Rajya Sabha on the 7th May, 1984, regarding bleak promotional prospects

in the Directorate General of Employment and Training and state:

- (a) whether it is a fact that out of the 32 posts of Key Punch Operators (Grade Rs. 260-400 plus Rs. 20 special pay) only 2 are holding supervisory posts (Grade Rs. 330-480), 4 are holding senior grade supervisory posts (Grade Rs. 330-480 plus Rs. 20 Special Pay), 5 are stagnating for the last 25 years; 7 for the last 20 years, and 10 are stagnating for the last 10 years or more and there is hardly any promotional chances for them in the near future; and
- (b) if so, what improvements in the service conditions his Ministry propose for the employees in the Data Processing Unit as a whole and for the Key Punch Operators in particular?

THE MINISTER OF STATE IN THE MINISTRY OF LABOUR AND REHABILITATION (SHRI DHAR-MAVIR): (a) There are 2 posts of Key Punch Operator Supervisors in the pay scale of Rs. 330-480, 5 posts of Key Punch Operators (Selection Grade) in the pay scale of Rs. 330-480 with special Pay of Rs. 20 - p.m. and 25 posts of Key Punch Operators in the pay scale of Rs. 260-400 with Special Pay of Rs. 20 p.m. None of the incumbents against these posts have been stagnating for 10 years or more.

Apart from being promoted as Technical Assistants (Hollerith), the Key Punch Operators/Key Punch Operator Supervisors can also be promoted as Junior Investigators/Statistical Assistants in the pay scale of Rs. 425-700. At present promotions are being made in accordance with the exsting Recruitment Rules.

(b) Matters including conditions of service relating to Central Government employees are before the 4th Central Pay Commission.

Not only has the promotion quota for the post_s of Junior Investigators/ Statistical Assistants from the Junior

Computers Comptometer Operators and Key Punch Operator Supervisors/ Key Punch Operators been increased from 25 per cent to 60 per cent and from 20 per cent to 40 per cent res pectively, but also the 40 per cent quota for direct recruitment and 15 per cent quota for deputation of the Upper Division Clerks/Lower Division Clerks/Stenographers has been abolished by amending the relevant recruitment rules, with effect from 20th August, 1983, in order to better promotional chances of the Key Punch Operators and Key Punch Operator Supervisors.
