to examine Conversion of Coal into Gaseous and Liquid Fuels, alter considering recommendations of the various committees including Ghosh Committee, in their report submitted to the Government in May 1984. have recommended against the immediate implementation of a programme ior producing synthetic fuel from coal on account of the High expenditure cost involved in such a programme.

There is no proposal under consideration of the Govt, to use alcohol in substitution of petiol or in admixture with petrol, as automotive fuel as the country is not deficient in this product.

THE MINISTER OF STATE IN THE DEPARTMENT OF COAL IN MINISTRY OF ENERGY .(SHRI DALBIR SINGH): (a) to (c) The Geological Survey of India has carried out large scale mapping during 1976-77 and 1977-78 field sessions, which established the existence of 5 to 6 thin lenticular coal horizons renging in thickness from 0.4 metres to 1.66 metres over a strike length of 15 km in the area bounded by Lish river in the West and Chel river in the East. However, due to tectonic disturbances the coal is cruched and rarely eccurs as lumps, and as such no reliable estimate of reserves can made. The information gathered so far f£om surface observations do not warrant any large scale mining in the area.
