- THE MINISTER OF CHEMICALS AND FERTILIZERS (SHRI VASANT SATHE): (a) and (b) Yes, Sir, Abbott has been issued notice with directions on prices of Erythrocin tablets. Further action wiH depend on the reply received from the company.
- (c) In the COR applications submitted by M|s. Abbott Laboratories the value of plant and machinery was shown as Rs. 7.44 lakhs. In the Industrial Licence application submitted by the company in March, 1977 for manufacture of Diethyl Malonate etc. at Ankleshwar, Gujarat, the value of existing plant and machinery was shown as Rs. 85.04 lakhs. 1032 RS-7

(d) No final view has so far been taken on the question whether the additional plant and equipment installed by the company was unauthorised or not. Hence the question of taking action against the company does not arise.

(e) Except with respect to Eryhrocin Tablets no instance of M|s. Abbott Laboratories marketing any other price controlled formulations without price approval has come to the notice of my Ministry.
