

Re-Endorsement of Capacity of Drug Companies

1993. SHRI BHUBANESWAR KALITA. Will the Minister of CHEMICALS AND FERTILIZERS be pleased to state;

(a) what was the licensed capacity of the items in respect of which re-endorsement of capacity was allowed to various companies under the 1982 and 1983 Policies, separately;

(b) what was the investment given in the applications based on which the capacities were licensed;

(c) when and what were the additions made in the investment by the companies concerned and whether such additional investments were approved by Government;

(d) what are the names of the companies where Government have found it expedient to inspect the premises in order to verify the details of plant and machinery installed; and

(e) what are the names of the companies inspected so far for the purpose and what are the findings of the

inspections and the items where unauthorised expansion/production were involved?

THE MINISTER OF CHEMICALS AND FERTILIZERS (SHRI VASANT SATHE): (a) The requisite details in respect of 29 cases finalised under April 1982 Policy have since been furnished while replying to Unstarred Question No. 2826 answered on 22nd August, 1983. Under April, 1983 Policy, 10 cases have so far been finalised. The details in respect of seven cases have already been supplied while replying to Unstarred Question No. 745 on 5th March 1984. Similar details in respect of 7 more cases subsequently finalised under April, 1982 Policy and 3 under April, 1983 Policy are given in the enclosed statement (See below).

(b) and (c) The details regarding investment were not required to be submitted while applying for re-endorsement of capacity.

(d) and (e) The requisite information has already been made available while replying Unstarred Question No. 1349 on 6th August, 1984.
