National Highway No 31A

SHRI LEONARD SOLOMAN SARING:

Will the Minister of DEFENCE be pleased to state:

- (a) whether it is a fact that the National Highway No. 31A which had been severely affected by the 1968 floods is still in a state of disrepair and not fit for vehicles of more than five metric tonnes of weight;
- (b) if so, what are the reasons therefor; and
- (c) by when it is proposed to bring to the standard of National Highway?

THE MINISTER OF STATE IN THE MINISTRY OF DEFENCE (SHRI K. P. SINGH DEO): (a) to (c) National Highway 31-A has already been restored to National single lane Highway standards. However, out of a total of 26 bridges on this National Highway requiring replacement by permanent bridges, 11 bridges have already been completed, 4 are under construction and the planning/ construction of the remaining bridges are in hand. These are planned to be replaced by permanent structures during the next 8 years or so, when the bridges would become capable of taking heavy vehicular traffic.
