THE MINISTER OF STATE THE MINISTRIES OF EDUCATION AND CULTURE AND SOCIAL WEL-FARE (SHRIMATI SHEILA KAUL): The late Maulana Saheb's birthday which falls on 11th November is being celebrated as Foreign Students' Day by the Indian Council of Cultural Relations (ICCR). This is being celebrated in prominent university towns in collaboration with Universities, Rotary Clubs and voluntary organisations. The I.C.C.R. is also organising the Azad Memorial Lectures since 1960 on February 22. every year, which is the death anniversary of Maulana Saheb.

Soviet Joint Committee on Shipping held in Odessa (USSR) from May 17 to May 28, 1984?

THE MINISTER OF STATE IN THE MINISTRY OF SHIPPING AND TRANSPORT (SHRI Z. R. ANSARI): Main subjects Discussed and Important Decisions taken during the sixth session of the Indo-Soviet Joint Committee on Shipping held at ODESSA (USSR) from May 17-22, 1984

- 1.0. Review of Implementation of decisions Incorporated in the previous, protocol.
- 1.1. Determination of weight of Fertilizer shipped from USSR to India.

It was decided that the present procedure for determining the weight of fertilizers at the Soviet Ports by means of automatic weighing scales may continue.

1.2. Settlement of claims for shipment of fertilizers from USSR to India:

It was recommended that the representatives of Sellers, Receivers and Shipowners may meet and settle the disputes on a Working Group Level and the progress be reviewed at the Commercial Level meetings.

13. Outstanding claims pertaining to foodgrains Demurrage/Despatch for rice shipments.

It was decided that these claims will be discussed and sorted out at the Commercial Level by a Joint Working Group including various agencies on the Soviet and Indian sides.
