Reappearance of shop_s in front 'of Red Fort

2332. SHRIMATI PRATIBHA SINGH: Will the Minister of WORKS AND HOUSING be pleased to state:

- (a) whether Government are aware that a large number of shops have reappeared after a lapse of one month in front of the main gate entrance of the Red Fort, during May-June, 1984 in connivance with the officers of the Municipal Corporation of Delhi;

- (c) whether it is also a fact that thousands of foreign and Indian visitors have made complaints about the nuisance created by these shop-keepers; and
