THE MINISTER OF STATE IN THE MINISTRIES OF EDUCATION AND CULTURE AND SOCIAL WEL-FARE (SHRIMATI SHEILA KAUL): (a) and (b) The Estimates Committee of the 7th Lok Sabha in its 77th Report on the Ministry of Home Affairs (Department of Personnel & A.R.) has recommended creation of an All-India Service in the field of Education. The proposal is yet to be examined.

# Late selection of Indian Olympics contingent

Will the Minister of SPORTS be pleased to state:

(a) the reasons for the late selection of the Indian Olympics contingent for the Games at Los Angeles; and

(b) the reasons for the late announcement and frequent changes in the selection of the Chef-de-Mission for the Indian contingent to the Olympics?

THE DEPUTY MINISTER IN THE DEPARTMENT OF SPORTS (SHRI ASHOK GEHLOT) (a) and (b) The selection of Indian Olympic contingent for Olympic Games as also that of Chef-de-Mission of the contingent is done by Indian Olympic Association. The first batch of Indian Olympic contingent arrived in Olympic Village at Los Angeles 11 days in advance and the second batch arrived 8 days in advance of the opening of XXIII Olympic Games.
